Purpose: To ensure that Medicaid members enrolled in the State of Michigan incur no cost sharing for their services.

Scope: Operations

Responsibilities: Claims processors

Definitions: None

Standards and Guidelines:

- A. Providers will be informed that payment from SWMBH is payment in full for services rendered.
- B. Providers including out of network providers who attempt to balance bill an enrollee will be referred to Provider Network Management and Program Integrity/Compliance for follow-up.
- C. Enrollees who present a bill for services that they have paid out-of-pocket will be promptly reimbursed and the provider contacted for future instances.
- D. This policy will apply to both in-network and out-of-network providers.
