

- Have full Medicare and full Medicaid
- Are 21 years of age or older
- Live in one of SWMBH's eight service areas

MI Health Link offers many benefits to enrollees. Some of these benefits include:

- Care Coordination
- An extensive provider network offering mental health services and substance use disorder treatment
- Community-based services such as: Community Living Supports, ACT Team Services, and Case Management
- Services with in-network providers are available at no cost to members
- Outpatient Services include: therapy and psychiatric medication management

## **MI Health Link Ombudsman Program (MHLO)**

- Empower you and provide support in resolving problems with your health care, behavioral health care, and long-term services and supports;
