Jennifer Harrison, PhD, LMSW, CAADC is a faculty member and field coordinator for the School of Social Work at Western Michigan University. Jennifer has been in clinical and administrative practice for over 20 years, and has teaching expertise in clinical and evidence-based practices, field education, and social policy. She has designed and led interprofessional courses in Guatemala focused on community health and permaculture, and has presented nationally and internationally on advanced quantitative analysis of evidence-based practice implementation. Her clinical work is focused on integrated medical and behavioral health using evidence-based methods. Jennifer's research interests include social and economic justice in social work education, co-occurring mental health, substance abuse, and medical needs among adults, peer services in behavioral health services, and food insecurity and sovereignty.

## Learning Objectives

- Understand individual and group in person and remote supervision models and well as ethical standards for supervision of students and limited licensed social workers
- Practice providing feedback to consumers, students, and colleagues in a way that enhances learning and upholds ethical standards
- Develop a plan to incorporate small supervision and practice changes to impact inclusion of diverse student, client, and worker groups into social work practice
- Develop knowledge about the guidelines for narcotic use to prescribers, and the likely impact on social work practice
- Provide quick and efficient screening within a variety of practice settings for individuals who are at trafficking risk

### Description of Training:

Ethical supervision and practice is an essential part of social services practice, and contributes to the workforce development of social workers of the future. Ethical practice manages liability and assures that we are practicing within our code of ethics and licensure standards as social workers, chemical addictions counselors, counselors, and psychologists. Supervision done well provides students and colleagues with the needed development as professionals, and provides supervisors with an opportunity to view their practice through fresh eyes. Ethical standards in practice and supervision, best practice models for ethical decision-making, and practice and supervision in diverse environments towards enhanced cultural humility for practitioners and organizations will be reviewed.

In addition, recent trends involving opiate use, misuse, dependence, and overdose have impacted most social work organizations. Learn about the recent Centers for Disease Control and Prevention (CDCP) guidelines for prescribers, and how this impacts pain management and addiction treatment for the clients of social work in a variety of settings.

Finally, human trafficking is an increased risk for youth and adults internationally, and in Southwest Michigan. Trafficking trends in labor, sex, and drug trafficking locally and internationally will be reviewed as well as emerging best practices for identification of persons who could be trafficked.
